We agree to supply you with product at a 50% discount off of retail pricing.

You agree to send a digital photo of your store front. (Pictures will be displayed on our website.)

You must agree to display Real Milk Paint window cling.

You must agree to stock products for resale.

You must agree to sell products at the suggested retail or higher.

You must agree to sell products in original Real Milk Paint packaging.

An order of \$200.00 must be placed annually in order to maintain your status as a distributor. If you exceed a years' time, you will revert back to retail pricing until wholesale agreement is reestablished.

The wholesale level receives:

First order is a minimum of \$500.00. Any order thereafter, can be any dollar amount. In order to maintain your purchasing level, a purchase of \$200.00 has to be made annually. If this does not occur, you will revert to full retail pricing and a new agreement will need to be signed and an initial opening order of \$500.00 will incur.

Drop shipments will have a \$5.00 surcharge plus the full price of shipping.

Free brochures will be included in every order, unless requested otherwise.

Free listing on our website and a link to your website will be provided.

Free Real Milk Paint window cling will be provided with each initial order and 2 **5x7 table top signs**.

Free Apron will be provided with initial order.

Payment for orders will be made with credit card or Paypal invoicing. No COD's are accepted. Payment must be received prior to shipping.
